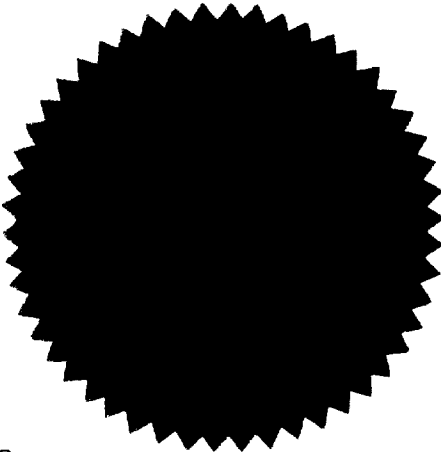

SECRETARY OF STATE

Pursuant to the provisions of the Iowa Business Corporation Act, the corporation hereinafter named (the "corporation") does hereby submit the following Articles of Amendment.

1. The name of the corporation is **LinkUSA Corporation**.

2. Article I of the Articles of Incorporation of the corporation is hereby amended to read as follows:

"The name of the corporation is: **Frontier Advanced Service Technologies Inc.**

3. The date of adoption of the aforesaid amendment was June 26, 1997.

4. Article II of the Articles of Incorporation of the corporation shall be amended by deleting the reference to "15,000,000" and inserting "10,000" in lieu thereof.

5. The date of adoption of the aforesaid amendment was July 15, 1996.

6. The designation, the number of outstanding shares, the number of shares entitled to be cast by the voting group entitled to vote on the said amendments, and the number of votes of the voting group indisputably represented at the meeting at which the said amendments were approved are as follows:
