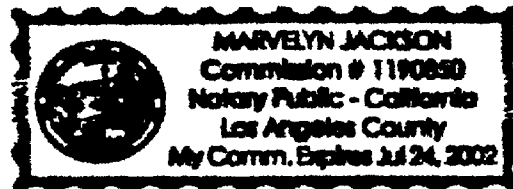
3. Fremont Financial Corporation has dissolved its interest in the Cookstore marks.




