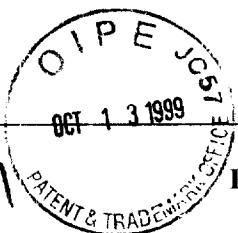

2. The following amendment (the "Amendment") to  
the Amended and Restated Certificate of Incorporation  
of the Corporation was approved by the directors  
and thereafter duly adopted by the holder of
