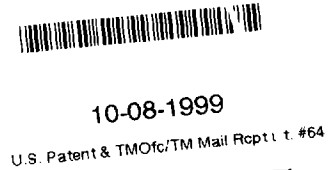

TRADEMARK ASSIGNMENT

This Trademark Assignment is by and between Ludlow Corporation, a Massachusetts corporation (hereinafter "LUDLOW") and The Ludlow Company LP, a Delaware limited partnership composed of Graphic Controls Corporation, a New York Corporation, (hereinafter "THE PARTNERSHIP").
