

1. Allied Corporation (formed under the name "Allied Chemical & Dye Corporation"), a corporation of the State of New York (the "surviving corporation"), owns all of the outstanding shares of The Bendix Corporation (formed under the name "Bendix Aviation Corporation"), a corporation of the State of Delaware.

2. The designation and number of outstanding shares of the subsidiary corporation to be merged and the number of such shares owned by the surviving corporation are as follows:

3. (a) The certificate of incorporation of Allied Corporation was filed by the Department of State on the 17th day of December, 1920.

(b). The Bendix Corporation was incorporated under the laws of the State of Delaware on April 13, 1929, and its application for authority to do business in the State of New York was filed by the Department of State on the first day of July, 1938.

4. The surviving corporation owns all of the outstanding shares of the subsidiary corporation to be merged.

5. The merger shall be effective on April 1, 1985.

6. The Plan of Merger was adopted by the Board of Directors of the surviving corporation.
