
RELEASE FROM TRADEMARK SECURITY AGREEMENT

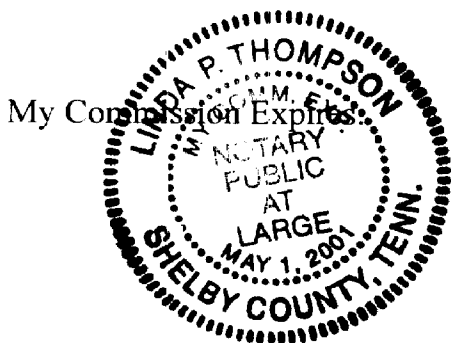
