**TERMINATION, RELEASE AND REASSIGNMENT
OF SECURITY INTERESTS IN TRADEMARKS**

Reference is made to that certain Trademark Security Agreement, dated as of May 3, 1999 (the "Security Agreement"), between Boone International, Inc., a California corporation ("Borrower"), and FINOVA Capital Corporation, a Delaware corporation ("FINOVA"), pursuant to which Borrower assigned FINOVA a continuing security interest in all then existing and thereafter acquired or arising Trademark Collateral as security for the prompt payment and performance of Borrower's obligations and liabilities owing to FINOVA under the Loan Agreement. Any initially capitalized terms not defined in this Termination, Release and Reassignment of Security Interest in Trademarks (this "Termination") shall have the definitions ascribed thereto in the Security Agreement.

1. FINOVA hereby acknowledges that, as of the date hereof, all of Borrower's obligations to FINOVA secured by the Trademark Collateral have been satisfied in full,

2. FINOVA, hereby assigns, conveys, grants, transfers and releases, without recourse, representation or warranty whatsoever, to Borrower all rights, title and interest in and to all the Trademark Collateral, and FINOVA shall execute and deliver to Borrower all deeds, assignments, and other instruments as may be necessary or proper to terminate all of the security interest granted by Borrower under the Security Agreement as are reasonably requested by Borrower, in form and substance reasonably satisfactory to Borrower, and to re-vest in Borrower all of FINOVA's rights in and to the Trademark Collateral, including, but not limited to those state (including common law) and federal trademarks, service marks and trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, including all licenses therefor held by Borrower, and all applications filed or to be filed in connection therewith, listed on Schedule A attached hereto and made a part hereof, and including the right to recover for all past, present and future infringement or unauthorized use thereof and all reissues, divisions, continuations, continuations-in-part, substitutes, renewals, and extensions thereof, all improvements thereon, and all other rights of any kind whatsoever accruing thereunder or pertaining thereto and subject to all existing license agreements with respect thereto.

3. FINOVA hereby agrees and confirms that the filing of the Security Agreement with the United States Patent and Trademark Office is canceled and terminated, and does hereby cancel and terminate all rights and obligations of Borrower under the Security Agreement.
