No. 1,531,100, covering BREWSKI for flavored and seasoned miniature seasoned snack crackers; various state registrations covering BREMNER, BREWSKI SNACKS, and BREWSKI CAJUN SNACKS; Canadian Trademark Reg. No. 378,182, covering BREWSKI for flavored and seasoned miniature snack crackers; U.K. Trademark Reg. No. 1,558,276, covering BREMNER WAFERS AND DESIGN for crackers, wafers, biscuits, preparations made from cereals, cookies, and snack foods; Benelux Trademark Reg. No. 536,756, covering BREMNER; and German Trademark Reg. No. 2,078,234, covering BREMNER (collectively the "Registrations"), and

WHEREAS, Rosseau Inc., a Delaware corporation having a place of business located at 2481 Kingsway Drive, P.O. Box 1058, Kitchener, Ontario, Canada N2G 4G4 ("Assignee"), is desirous of acquiring an interest in and to the Marks and Registrations.
