ASSIGNOR also hereby assigns to ASSIGNEE all rights of action in law and in equity, all claims and causes of action for infringement of trademark rights assigned herein, including the right to sue for, and collect damages for, any and all acts of past and future infringement.

This assignment and sale shall be and is hereby made effective October 1, 1998
