

WHEREAS, GRS has registered the trademark GET READY for "sportswear, namely T-shirts, shorts, and sweatshirts" in the United States Patent and Trademark Office ("PTO") as Registration No. 1,976,817;

WHEREAS, GRS, Stone and Gearheard represent and warrant to Jennifer A. O'Malley, as agent for an unidentified principal, that GRS is the sole owner of all right, title and interest in the GET READY trademark and federal trademark Registration No. 1,976,817 and that no other person or entity has any security interest, or any interest of any kind in said trademark or registration or has made any claim of interest thereto, that GET READY is free and clear from all encumbrances, including any licenses, that GRS, Stone and/or Gearheard have not been charged with trademark or service mark infringement or unfair competition by any third party relating to use of GET READY; and that GRS, Stone and/or Gearheard are not aware of any claims, objections or protests relating to use or registration of GET READY; and

WHEREAS, Jennifer A. O'Malley, c/o Pattishall, McAuliffe, Newbury, Hilliard & Geraldson, 311 South Wacker Drive, Suite 5000, Chicago, IL 60606, as an agent for an unidentified principal, is desirous of acquiring all right, title and interest in and to said GET READY trademark throughout the world and said federal trademark Registration No. 1,976,817 and the goodwill of the business in connection with which the GET READY trademark is used;

NOW THEREFORE, for good and valuable consideration, receipt of which is





In exchange for and as full consideration for this assignment of all such rights, title and interests, Jennifer A. O'Malley agrees, in her capacity as an agent for an unidentified principal, to pay the total sum of five thousand dollars (\$5,000) to GRS, Stone and Gearheard, by sending a check in that amount made payable to GRS, Karie Gearheard and Maria Stone to Karie Gearheard, 8511C Turtle Creek Blvd., Dallas, Texas 75225, via Federal Express overnight delivery within seven (7) days following Jennifer A. O'Malley's receipt of the properly executed original Assignment. This sum constitutes the entire amount that is due and payable from Jennifer A. O'Malley pursuant to this Assignment, with no additional sums due or owed.

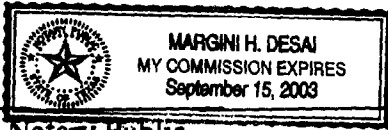
