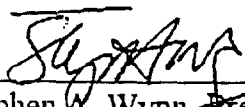
RESOLVED, that the Articles of Incorporation of the Corporation be amended by deleting existing ARTICLE FIRST in its entirety and replacing it with the following:

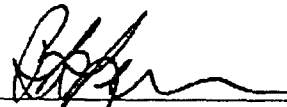
"FIRST: The name of this corporation is:
