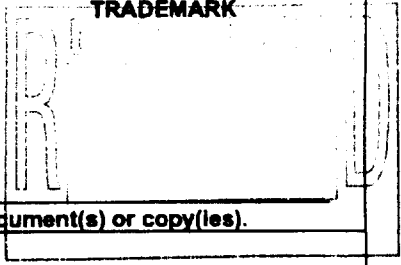

TO THE ARTICLES OF INCORPORATION

Pursuant to the provision of West Virginia Code § 31-1-31, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation;

**I.** The name of the corporation is Snowshoe Resort Management, Inc.

**II.** The following amendment of the Articles of Incorporation was adopted by the board of directors and the sole shareholder of the corporation by written agreements pursuant to West Virginia Code § 31-1-73 on January 12, 1999, in the manner prescribed by West Virginia Code §§ 31-1-107:

Article I of the Corporation's Articles of Incorporation shall be amended to read in its entirety as follows:

**I.** The name of the corporation shall be Snowshoe Mountain, Inc.

**III.** At the time of the adoption of the amendment, the corporation had one hundred (100) shares of common stock issued and outstanding, all of which shares were entitled to vote on the amendment. There were no shares of any other class issued and outstanding.

**IV.** The number of shares voting for the amendment was one hundred (100), and the number of shares voting against the amendment was zero (0).

These Articles of Amendment are dated this 14<sup>th</sup> day of April, 1999.
