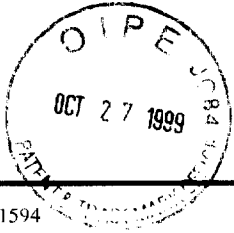

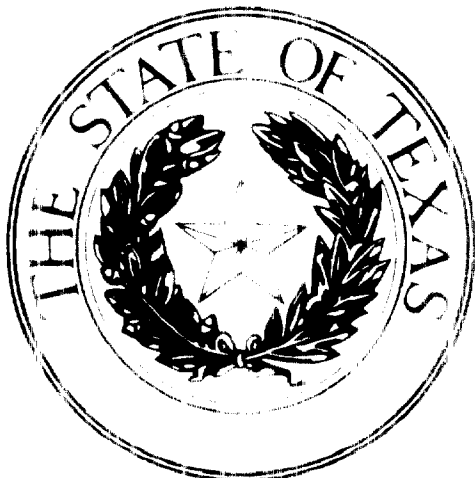

TO THE

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Las Dawic, Inc.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on the 5th day of June, 1998.

The amendment alters Article One of the original Articles of Incorporation. The full text of each provision altered is as follows:

“Article One

“The name of the Corporation is GDH International, Inc.”

ARTICLE THREE


The number of shares of the corporation outstanding at the time of such adoption was One Million Fifty-Three Thousand Three Hundred Thirty-Three (1,053,333).
