U.S. Trademark Assignment

ASSIGNMENT made this 21st day of October 1999, by SPECTRAVEST, INC., a California corporation with an office and place of business at 310A Shaw Road, South San Francisco, California 94080 ("Assignor").

WHEREAS, Assignor is the owner of and has adopted but is currently not using U.S. Trademark Registration Number 1,964,866 for the SCOOP mark (the Mark); and,

WHEREAS, Joseph Sakoda, an individual with an office and place of business at P.O. Box 3605, Cerritos, California 90703 ("Assignee") wishes to acquire Assignor's right, title, and interest in and to the Mark; and,

WHEREAS, Assignor wishes to assign the Mark to Assignee.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the owner of the entire right, title and interest in and to the Mark, for the sole use and enjoyment of the Assignee, his successors, assigns or other legal representatives.

Assignor warrants and represents that the Mark has not been previously assigned or encumbered in any manner and that it is free and clear of all liens and claims.

Assignor shall further render such other assistance as may be reasonably required by Assignee to record his ownership rights of the Mark in the United States.

Any and all costs in connection with this Assignment and recordation thereof shall be paid by Assignee.
