TRADEMARK ASSIGNMENT

Except for the representations and warranties which are specifically set forth in that certain Asset Purchase Agreement (the "Purchase Agreement") dated as of September 29, 1999 among Assignor, Assignee and the shareholders of Assignor listed therein, the Assignor makes no representations or warranties with respect to assets transferred hereby.

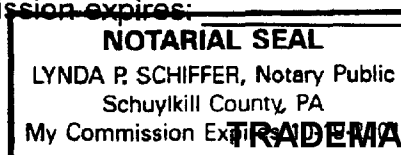
