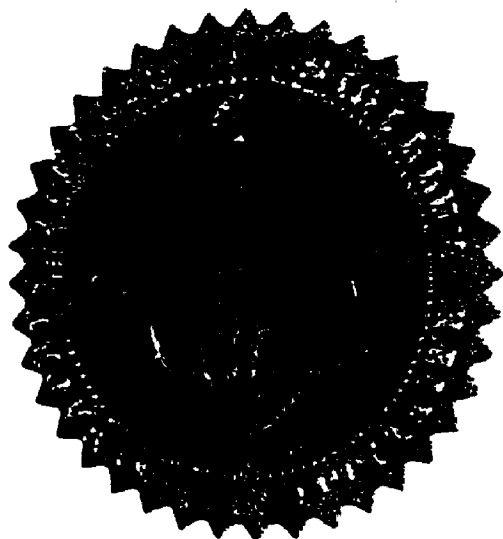
MASSACHUSETTS MUTUAL LIFE INSURANCE COMPANY
