ASSIGNMENT AND RELEASE OF  
PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

WHEREAS, pursuant to that certain Patent, Trademark and Copyright Security Agreement (the "Security Agreement") dated as of April 7, 1999, made by FEDERAL EMPLOYEES' DISTRIBUTING COMPANY ("Borrower"), FEDCO CREDIT CORPORATION ("FEDCO Credit"), NATIONAL EAGLE CONSTRUCTION CO. ("National"), FEDOPTICS, INC. ("FEDOPTICS"), TOSARI INC. ("Tosari"), MEDCO PHARMACIES, INC. ("MEDCO"), FEDCAL DISTRIBUTING COMPANY ("FEDCAL"), and FEDCO ESCONDIDO PARTNERSHIP L.P. ("Escondido") (Borrower, FEDCO Credit, National, FEDOPTICS, Tosari, MEDCO, FEDCAL and Escondido being referred to collectively as "Grantors" and each individually as a "Grantor"), in favor of GENERAL ELECTRIC CAPITAL CORPORATION, as agent ("Agent"), each Grantor granted to Agent a security interest in such Grantor's interest in and to the Intellectual Property Collateral (as defined therein), including the Trademarks described in Schedule I (Part B) attached thereto and the Copyrights described in Schedule I (Part C) attached thereto; and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on April 9, 1999 at Reel/Frame 1897/0082; and

WHEREAS, the Security Agreement was recorded with the United States Copyright Office on April 9, 1999 at Volume 3426, page 606; and


WHEREAS, Agent desires to release its security interest in the Intellectual Property Collateral and terminate the Security Agreement.

## PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

THIS PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Agreement"), dated as of July 13, 1999, is made by FEDERAL EMPLOYEES' DISTRIBUTING COMPANY, a California nonprofit mutual benefit corporation, as Debtor and Debtor in Possession ("Borrower"), FEDCO CREDIT CORPORATION, a California corporation ("FEDCO Credit"), NATIONAL EAGLE CONSTRUCTION CO., a California corporation ("National"), FEDOPTICS, INC., a California corporation ("FEDOPTICS"), TOSARI INC., a California corporation ("Tosari"), MEDCO PHARMACIES, INC., a California corporation ("MEDCO"), FEDCAL DISTRIBUTING COMPANY, a California corporation ("FEDCAL"), and FEDCO ESCONDIDO PARTNERSHIP L.P., a California limited partnership ("Escondido") (Borrower, FEDCO Credit, National, FEDOPTICS, Tosari, MEDCO, FEDCAL and Escondido being referred to collectively as "Grantors" and each individually as a "Grantor"), in favor of GENERAL ELECTRIC CAPITAL CORPORATION, a New York corporation, as agent (in such capacity, "Agent") for the lenders ("Lenders") from time to time parties to the Credit Agreement (as defined below).

### RECITALS

A. Pursuant to that certain Debtor in Possession Credit Agreement of even date herewith by and among Grantors, Lenders and Agent (including all annexes, exhibits and schedules thereto, and as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), Agent and Lenders have agreed to extend certain financial accommodations to or for the direct or indirect benefit of Grantors.

B. In order to induce Agent and Lenders to enter into the Credit Agreement and the other Loan Documents and to induce Agent and Lenders to extend the financial accommodations as provided for in the Credit Agreement, Grantors have agreed to execute and deliver to Agent, for the benefit of Agent and Lenders, that certain Security Agreement of even date herewith made by Grantors in favor of Agent, for the benefit of Agent and Lenders (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").

C. Pursuant to the Security Agreement, Grantors are required to execute and deliver to Agent, for the benefit of Agent and Lenders, this Patent, Trademark and Copyright Security Agreement.

### AGREEMENT

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantors and Agent hereby agree as follows:

1. Definitions. Unless otherwise defined herein, capitalized terms or matters of construction defined or established in Annex A to the Credit Agreement shall be applied

herein as defined or established therein. All other undefined terms contained in this Agreement, unless the context indicates otherwise, shall have the meanings provided for by the Code to the extent the same are used or defined therein.

2. Grant of Security Interest in Intellectual Property Collateral. To secure the prompt and complete payment, performance and observance of all of the Obligations, each Grantor hereby grants, assigns, conveys, mortgages, pledges, hypothecates and transfers to Agent, for the benefit of Agent and Lenders, in accordance with Section 364(c) and (d) of the Bankruptcy Code with respect to Borrower, a Lien upon all of its right, title and interest in, to and under the following prepetition and postpetition assets of such Grantor or such Grantor's estate, whether now owned by or owing to, or hereafter acquired by or arising in favor of, such Grantor (including under any trade names, styles or derivations of such Grantor), and whether owned by or consigned by or to, or leased from or to, such Grantor, and regardless of where located (collectively, the "Intellectual Property Collateral"):

- (a) all of such Grantor's Patents and Patent Licenses to which it is a party, including those referred to in Part A to Schedule I hereto;
- (b) all of such Grantor's Trademarks and Trademark Licenses to which it is a party, including those referred to in Part B to Schedule I hereto;
- (c) all of such Grantor's Copyrights and Copyright Licenses to which it is a party, including those referred to in Part C to Schedule I hereto;
- (d) all Goodwill, trade secrets, proprietary or confidential information, technical information, procedures, formulae, quality control standards, designs, operating and training manuals, customer lists, and other General Intangibles with respect to the foregoing; and
- (e) all Proceeds of the foregoing, including (i) any and all proceeds of any insurance, indemnity, warranty or guaranty payable to any Person from time to time with respect to any of the foregoing, (ii) any and all payments (in any form whatsoever) made or due and payable to any Person from time to time in connection with any requisition, confiscation, condemnation, seizure or forfeiture of all or any part of the foregoing by any Governmental Authority (or any Person acting under color of Governmental Authority), (iii) any claim of any Person against third parties for (A) past, present or future infringement of any Patent or Patent License, (B) past, present or future infringement of any Copyright or Copyright License, (C) past, present or future infringement or dilution of any Trademark or Trademark License, or (D) injury to the Goodwill associated with any Trademark or Trademark License, (iv) any recoveries by any Person against third parties with respect to any litigation or dispute concerning any of the foregoing, and (v) any and all other amounts from time to time paid or payable under or in connection with any of the foregoing, upon disposition or otherwise.

Notwithstanding the generality of the foregoing, the "Intellectual Property Collateral" shall not
