

**ARTICLES OF AMENDMENT  
DOMESTIC BUSINESS CORPORATION**

In compliance with the requirements of 15 Pa.C.S. § 1915 (relating to articles of amendment), the undersigned business corporation, desiring to amend its Articles, hereby states that:

1. The name of the corporation is Maier's Bakery.
2. The address of this corporation's current registered office in this Commonwealth is 640 Park Avenue, Reading, Berks County, Pennsylvania.
3. The corporation was incorporated under the Act of the General Assembly of the Commonwealth of Pennsylvania, as shown by its Certificate of Incorporation, dated April 28, 1927.
4. The amendment shall be effective upon filing these Articles of Amendment in the Department of State.
5. The amendment was adopted by the shareholders pursuant to 15 Pa.C.S. § 1914(a) and (b).
6. The amendment was adopted by the board of directors pursuant to 15 Pa.C.S. § 1914(c).
