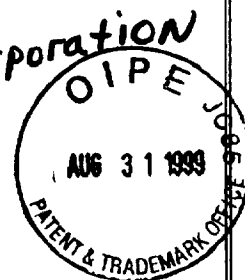

WHEREAS HERCON ENVIRONMENTAL CORPORATION, a Delaware corporation ("Assignor") did execute and deliver to IBJ WHITEHALL BUSINESS CREDIT CORPORATION (f/k/a IBJ SCHRODER BUSINESS CREDIT CORPORATION, successor in interest to IBJ SCHRODER BANK & TRUST COMPANY), AS AGENT ("Assignee") for itself and various other financial institutions (collectively, "Lenders") a certain Trademark Assignment of Security (the "Agreement"); and

NOW THEREFORE, for and in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee does hereby terminate its security interest and assigns, sells and transfers unto Assignor its entire right, title and interest in and to each of the Marks and the Registrations, together with that part of the goodwill of its business connected with the use of and symbolized by the Marks and Registrations, and does hereby further cancel and terminate the Agreement, declare the same null and void, of no further force and effect, and further states that Assignee has no further or continuing right, title or interest in or to any of the Marks or Registrations.


