

WITNESSETH



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all of its right, title and interest in and to the Marks, and more particularly, (i) the security interest in the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Uniform Commercial Code as in effect in the State of New York on the date hereof or under other relevant law) and products of the Marks, (iii) the goodwill of the business symbolized by the Marks and (iv) all causes of action arising prior to the date hereof for infringement of any of the Marks or unfair competition regarding the same; in each case to the extent granted to Collateral Agent by the Assignor by the Security Agreement, which Assignment was duly recorded on February 23, 1998, at Trademark Reel 1692, Frame 0449 in the United States Patent and Trademark Office.


