PATENT AND TRADEMARK SECURITY AGREEMENT

THIS AGREEMENT, made as of the 2nd day of September, 1999, by J&J Marketing, Inc., a Texas corporation and affiliate of Member Services, Inc. of Bentonville, Arkansas ("Borrower"), in favor of The Bank of Bentonville, an Arkansas corporation ("Lender"), with a place of business located in Bentonville, Benton County, Arkansas.

WITNESSETH:

WHEREAS, Borrower is the sole owner of all right, title, and interest in and to those certain United States patents and trademarks described on Schedule E of a certain Asset Purchase Agreement between Borrower and Whistler Corporation of Massachusetts, a Delaware Corporation, which is incorporated by reference and made a part hereof (hereinafter called the "Assets"); and

WHEREAS, Lender intends to extend loans and/or other financial accommodations to Borrower pursuant to a certain Loan and Security Agreement, dated September 2, 1999, between Borrower and Lender, together with any and all amendments now or hereafter made thereto, hereinafter called the "Loan Agreement"; and

WHEREAS, as a condition to advancing such loans and/or financial accommodations to Borrower under the Loan Agreement, Lender has required that Borrower grant to Lender a security interest in the Assets;

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Borrower agrees as follows:

1. Borrower hereby grants a security interest to Lender, its successors, and assigns, in the entire right, title, and interest of Borrower in and to the Assets. The Assets shall include, and Lender's security interest therein shall also cover,
 - A. All renewals;
 - B. All income, royalties, damages, and payments now and hereafter due and/or payable under and with respect thereto, including (without limitation) damages and

- C. The right to sue and recover for past, present, and future infringements thereof;
- D. All rights corresponding thereto and throughout the world; and
- E. All other proceeds and products of the foregoing, including (without limitation) any rights pursuant to its agreements with any other party relative thereto.

The Assets shall serve as collateral to secure the complete and timely satisfaction of all the Obligations (as defined in the Loan Agreement and hereinafter called the "Obligations") and shall be subject to all of the terms and conditions of the Loan Agreement.

2. Such security interest shall be accompanied by a power of sale, to the extent permitted by law, upon the occurrence and during the continuation of an Event of Default (as defined in the Loan Agreement and hereinafter called an "Event of Default").

3. Notwithstanding the foregoing, unless and until Lender exercises the rights and remedies accorded to it under the Loan Agreement or by law with respect to the realization upon its security interest in the Assets, Borrower shall own, and may use and enjoy, the Assets in connection with its business operations, but only in a manner consistent with the preservation of their current substance, validity, and registration and the security interest herein granted.

4. Borrower further agrees to take the following actions:

- A. While it is a secured party hereunder, Lender shall have no obligation or responsibility to protect or defend the Assets and Borrower shall at its own expense protect, defend, and maintain the same to the extent reasonably advisable for its business,
- B. Borrower shall register all additions to the Assets, including giving due consideration to value, importance, cost, and opinion of counsel as to availability of such registration/application,
- C. Borrower shall pay of all necessary fees, including maintenance fees, and file of all necessary documents as to maintain the Assets in good standing.

- D. Borrower shall employ patent and/or trademark notices in compliance with applicable legal requirements or as permitted to maximize the protection and enforcement of the Assets,
- E. Borrower shall use its best efforts to uncover any infringement of the Assets and forthwith advise Lender in writing of any infringement so discovered,
- F. Borrower shall prosecute any material infringement of the Assets, giving due consideration to value, importance, cost, and opinion of counsel as to such action, and
- G. If Borrower fails to comply with the foregoing, Lender may do so in Borrower's name, or in Lender's name but at Borrower's expense, and Borrower shall reimburse Lender for all expenses, including reasonable attorney's fees, incurred by Lender in protecting, defending, and maintaining the Assets owned by Borrower.

5. The security interest in the Assets granted hereunder shall remain in full force and effect until the Obligations are satisfied in full and the Loan Agreement is terminated. At such time Lender shall, if requested by Borrower, execute and deliver to Borrower, or to a third party upon Borrower's instructions, for filing with the United States Patent and Trademark Office and in each office in which any financing statement pertaining to the security interest granted hereby may have been filed, (1) documentation in accordance with the rules and regulations of said office, (2) termination statements under the Uniform Commercial Code, and (3) any other documentation reasonably requested by Borrower, all as may be necessary to release Lender's interest in the Assets, and all at the cost and expense of Borrower.




