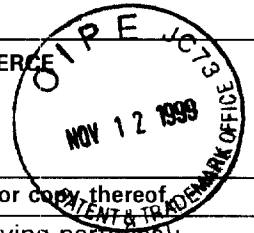

THIS AGREEMENT is dated as of June 18, 1999.


