

Pursuant to the provisions of Section 14A:9-2(4) and Section 14A:9-4(3), Corporations, General, of the New Jersey Statutes, the undersigned corporation executes the following Certificate of Amendment to its Certificate of Incorporation:

- 1. The name of the corporation is Ceridian Minidata Small Business Solutions, Inc.
- 2. The following amendment to the Certificate of Incorporation was approved by the directors and thereafter duly adopted by the stockholders of the corporation on the 23rd day of December, 1998:

Resolved, that Article 1 of the Certificate of Incorporation be amended to read as follows:
