

Pursuant to the provisions of Section 14A:9-2(4) and Section 14A:9-4(3), Corporations, General, of the New Jersey Statutes, the undersigned corporation executes the following Certificate of Amendment to its Certificate of Incorporation:

1. The name of the corporation is Minidata Services, Inc.
2. The following amendment to the Certificate of Incorporation was approved by the directors and thereafter duly adopted by the stockholders of the corporation on the 30th day of March, 1998:

Resolved, that Article 1 of the Certificate of Incorporation be amended to read as follows:

"The name of the corporation is Ceridian Minidata Small Business Solutions, Inc."

3. The number of shares entitled to vote upon the amendment was 425,732.
4.
