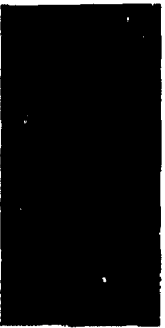

RELEASE AND REASSIGNMENT

This RELEASE OF SECURITY AGREEMENT ("Release"), dated as of May 23, 1997, is made by First Union National Bank of North Carolina ("Secured Party").

WITNESSETH:

WHEREAS, Mebane Packaging Group, Inc. ("Debtor"), with its principal place of business at 7411 Oakwood Street Extension, Mebane Industrial Park, Mebane, North Carolina 27302, and Secured Party are parties to that certain Security and Pledge Agreement, dated APRIL 11, 1991 ("Security Agreement");

WHEREAS, pursuant to the Security Agreement, Debtor granted a security interest and conditional assignment to Secured Party in the trademarks listed on **Schedule A** attached hereto (the "Trademarks");

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby terminates the Security Agreement and releases its security interest in, and reassigns, transfers and conveys to Debtor without recourse, representation or warranty, of any kind, all right, title and interest which Secured Party has in and to the Trademarks.

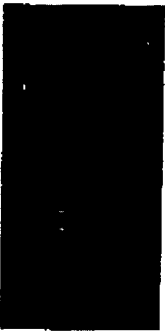
