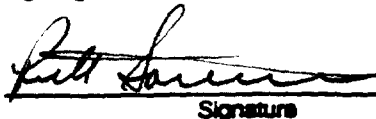

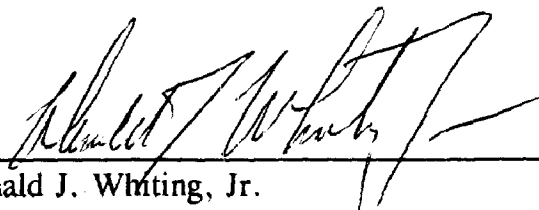
3. The certificate of incorporation is amended to change the name of the corporation.

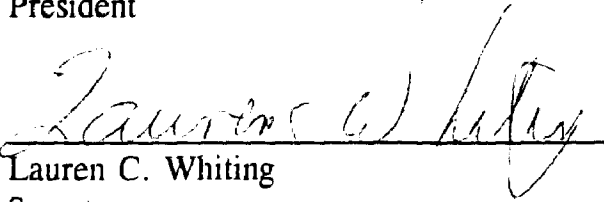
4. Paragraph First of the certificate of incorporation which refers to the corporate name is amended to read as follows:

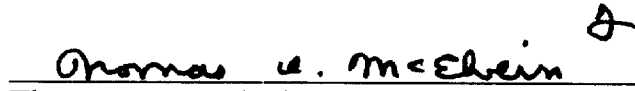
