1999 to be effective nunc pro tunc as of December 1996.

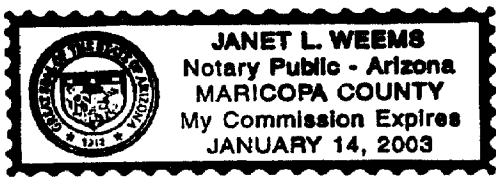
