

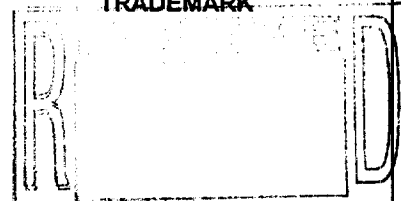

ASSIGNMENT

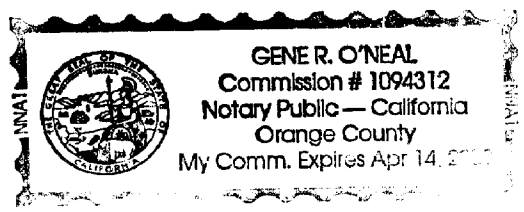
