## ASSIGNMENT OF INTELLECTUAL PROPERTY AGREEMENT

WHEREAS, Georgia Lighting Supply Co., Inc., a Georgia corporation, whose address is 530 Fourteenth Street, N.W., Atlanta, Georgia 30318 ("Assignor"), is the owner of intellectual property as described on the attached Schedule A ("Marks) and Schedule B ("Copyrights");

WHEREAS, Assignor, GL Acquisition Sub, Inc. ("GL Acquisition"), The Home Depot, Inc., Harry L. Gilham, Jr. and M. Ray Gardner have previously entered into an Asset Purchase Agreement, dated June 2, 1999 and as amended as of the date hereof (the "Purchase Agreement"), pursuant to which Assignor agreed to sell, convey, transfer and assign its business operations and certain assets of Assignor to GL Acquisition and GL Acquisition agreed to purchase, acquire and accept such business operations and assets of Georgia Lighting and to assume certain liabilities of Georgia Lighting;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, transfers, conveys and assigns to Assignee, all of Assignor's right, title and interest throughout the world in and to the Copyrights and Marks, including those listed on the attached Schedule A and Schedule B, if any, therefor, the right to recover for past infringement, and the good will of the business in connection with which they are or have been used.

Assignor agreed to sign any additional documents necessary to carry out the intent of this Agreement.

This assignment agreement shall inure to the benefit of and be binding upon the parties hereto and their successors and assigns.

This agreement shall be deemed to be made in, and in all respect shall be interpreted, construed and governed by and in accordance with the laws of, the State of Georgia.

The Purchase Agreement, by this reference thereto, is incorporated herein and made a part hereof
