

RELEASE OF TRADEMARK COLLATERAL SECURITY INTEREST

WHEREAS, pursuant to the Collateral Assignment of Trademarks as Security dated as of April 30, 1996 between WALTHAM BEEF COMPANY, INC., a corporation organized and existing under the laws of the State of Delaware (the "Borrower") and NATIONSBANK, N.A., a national banking association (the "Lender") and filed with the United States Patent and Trademark office on June 4, 1996 at Reel 1442, Frame 166 of the Trademark Record (the "Security Document"), the Lender became the holder of a security interest and conditional assignment in and to all of the right, title and interest in, under or by virtue of certain trademarks, trademark applications, licenses and other intangible assets owned by the Borrower and more particularly described on Schedule A attached hereto (the "Collateral"); and
