ASSIGNMENT OF TRADEMARKS



WHEREAS, ASSIGNOR is the owner of all right, title and interest in and to the trademarks CONCIERGE NETWORK and CN CONCIERGE NETWORK & Design and United States Trademark Registration Nos. 1,945,960 for CONCIERGE NETWORK registered on January 2, 1996 and 2,095,403 for CN CONCIERGE NETWORK & Design registered on September 9, 1997 at the United States Patent and Trademark Office; and
