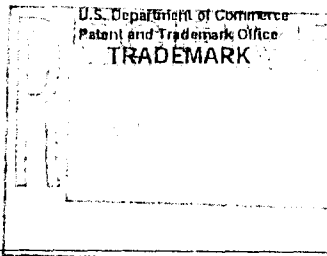



TRADEMARK ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT ("Assignment") is made this 9th day of November, 1999, by and between PACE INTERNATIONAL, LLC, a Washington limited liability company ("Buyer") and ECOSCIENCE PRODUCE SYSTEMS CORP., a Delaware corporation ("Seller").

RECITALS

The Buyer is purchasing the business (the "Business") and substantially all of the assets of Seller pursuant to that certain Asset Purchase Agreement dated November 4, 1999, by and among Buyer, Seller and EcoScience Corporation, the parent corporation of Seller (the "Asset Purchase Agreement").

The Seller has, in connection with the Business, adopted, used and is using various trademarks and has developed goodwill of the Business associated with said trademarks. Pursuant to the Agreement, Seller has agreed to sell, assign and transfer the trademarks and goodwill associated with the Business to Buyer, including those trademarks identified on Exhibit A hereto.

NOW, THEREFORE, for and in consideration of the mutual promises herein made, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged,

IT IS HEREBY AGREED AS FOLLOWS:

ASSIGNMENT

Seller by these presents sells, assigns and transfers to the Buyer, its successors and assigns, all its rights, interests, and title to said trademarks identified in Exhibit A attached hereto, together with the goodwill of the Business symbolized by said trademarks, and including any and all federal and state registrations or applications for registration of said trademarks.
