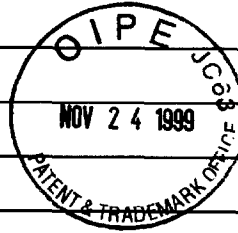

TRADEMARK ASSIGNMENT

WHEREAS, Assignor owned United States Trademark Registration No. 1,813,112 for the mark THE GREEK SPIRIT (hereinafter "the Mark") and the goodwill of the business symbolized thereby;

WHEREAS, Assignor did, on September 30, 1994 by separate instrument, assign certain of its assets and business to Assignee, including all right, title and interest in and to the Mark, and the goodwill of the business symbolized thereby; and
