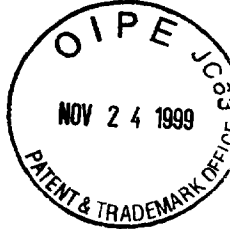

# TRADEMARK ASSIGNMENT

This Trademark Assignment is made by Metaxa International GmbH, a company incorporated and existing under the laws of Germany and having a principal business address at Bahnstrasse 10, D-65205 Wiesbaden, Germany (hereinafter "Assignor"), in favor of Indivined B.V., a company incorporated and existing under the laws of the Netherlands, having a principal business address at Kabelweg 37, P.O. Box 58002, 1040 HA Amsterdam, The Netherlands (hereinafter "Assignee").


WHEREAS, Assignor owned United States Trademark Registration No. 1,813,112 for the mark THE GREEK SPIRIT (hereinafter "the Mark") and the goodwill of the business symbolized thereby;

WHEREAS, Assignor did, on September 28, 1995 by separate instrument, assign certain of its assets and business to Assignee, including all right, title and interest in and to the Mark, and the goodwill of the business symbolized thereby; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby confirms having assigned, transferred and set over to Assignee, effective as of September 28, 1995, its entire right, title interest in and to the Mark and the goodwill symbolized by the Mark, including the right to sue for and receive all damages from past infringements of the Mark, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.
