PARTIAL RELEASE

PARTIAL RELEASE dated as of October 13, 1999 by **THE CHASE MANHATTAN BANK**, successor-in-interest to The Chase Manhattan Bank (National Association), not personally but in its capacity as administrative agent for the benefit of itself and the Lenders (as defined below) (the "Administrative Agent").

RECITALS:

WHEREAS, pursuant to that certain Credit Agreement dated as of June 14, 1996 (as amended, the "Credit Agreement"), among LCC, L.L.C., a Delaware limited liability company (together with its successor-in-interest, LCC International, Inc., a Delaware corporation, the "Company"), certain subsidiaries of the Company party thereto, the lenders party thereto (the "Lenders") and the Administrative Agent, the Lenders have extended credit to the Company and its subsidiaries;

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of June 14, 1996 and recorded on July 26, 1996 in Reel #1459, Frame #0701, the Company assigned and granted to the Administrative Agent a security interest in all right, title and interest of the Company in and to all trademarks; and

WHEREAS, the Administrative Agent has agreed to release its security interest in and to certain trademarks of the Company listed on **Annex A** and the applications and registrations thereof (the "Released Trademarks");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby terminate and release all of its right, title and interest in and to the Released Trademarks.
