ASSIGNMENT OF TRADEMARKS

ASSIGNMENT OF TRADEMARKS dated as of August 12, 1999 by Peter Schilder and Jane Schilder Knowles (collectively, the "Owners"), American Orthopsychiatric Association, Inc., a New York corporation ("Ortho"), and the Estate of Lauretta Bender (the "Estate": the Estate, the Owners and Ortho are referred to collectively hereinafter as the "Assignors"), to The Riverside Publishing Company, a Delaware corporation (the "Assignee").

WHEREAS, the Assignors have adopted, used and are using certain trademarks containing the word "Bender" (the "Assigned Marks"), including without limitation "The Bender Visual Motor Gestalt Test," and the Owners are the owners of United States registration number 1,198,662 for such a trademark (the "Assigned Registration"); and

WHEREAS, the Owners are beneficiaries of the Estate, and have authorized the use of the Assigned Marks by Ortho and the Estate; and


WHEREAS, Ortho, the Estate and the Assignee are parties to a Publishing Agreement of even date herewith (the "Publishing Agreement") providing, among other things, that Ortho and the Estate transfer to the Assignee certain assets, properties, and rights, including the Assigned Marks and the Assigned Registration, on the terms and conditions set forth in the Publishing Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignors do sell, assign, transfer and set over to the Assignee all of the Assignors' right, title and interest in and to the Assigned Marks and the Assigned Registration together with that part of the goodwill of the Assignors' business connected with the use of and symbolized by the Assigned Marks.

THE ASSIGNORS hereby irrevocably appoint the Assignee, its successors and assigns, as true and lawful attorneys of the Assignors to execute such further documents and instruments, and do such other acts and things as may be necessary or appropriate to effectuate the intentions hereof.






