TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, effective as of June 1, 1996 (the "Effective Date"), is by and between SDI Holding Corp. ("Assignor"); and Sterling Diagnostic Imaging, Inc. ("Assignee"). The Assignor and Assignee are collectively referred to herein as the "Parties."

WHEREAS, the Assignor is the owner of U.S. Trademark Reg. No. 1,941,101 for the trademark STERLING ("the Trademark");

WHEREAS, the Assignee is interested in acquiring the Trademark, including all domestic and foreign rights, registrations, applications, and common law rights in the Trademark from the Assignor and the Assignor is interested in transferring the Trademark to the Assignee.

3. Will, upon written request of Assignee, its successors and assigns, execute reasonable documents prepared at the expense of Assignee, its successors and assigns, to perfect its title to any and all rights in the Trademarks conveyed hereunder.
