


U.S. Trademark Application No. 75/059,011. The correct application no. should have been 75/059,511. The incorrect recitation was due to an inadvertent typographical error.

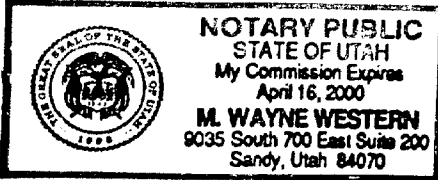
