STOCK PURCHASE AGREEMENT

This Stock Purchase Agreement (the "Agreement") is made and entered into as of October 15, 1997, by and among: Electronics for Imaging, Inc., a Delaware corporation (the "Purchaser"); Pipeline Associates, Inc., a New York corporation ("Pipeline, NY"), Pipeline Asia, Inc., a New Jersey corporation ("Pipeline NJ") (collectively, the "Pipeline Companies"), and Stephen Kochan ("Kochan") and Patrick Wood ("Wood") (collectively, the "Selling Shareholders"). Certain other capitalized terms used in this Agreement are defined in Exhibit A.

Recitals

A. The Selling Shareholders own Eight Thousand Five Hundred Fifty (8,550) shares of the common stock of Pipeline NY and One Hundred (100) shares of the common stock of Pipeline NJ (collectively, the "Shares"), which constitute all of the outstanding capital stock of the Pipeline Companies.

B. The Selling Shareholders wish to sell the Shares to the Purchaser on the terms set forth in this Agreement.
