RELEASE OF SERVICEMARK SECURITY INTEREST

RELEASE, dated this 1st day of July, 1999 in favor of HCX, Inc., a Delaware corporation, from the Chase Manhattan Bank, successor by merger of Chemical Bank New Jersey, National Association, a national banking association (the "Secured Party").

WHEREAS, pursuant to a Security Interest recorded in the United States Patent and Trademark Office on Reel No. 1280 at Frame No. 0275 on December 19, 1994 and amended and recorded in the United States Patent and Trademark Office on Reel No. 1367 at Frame No. 0283 on October 2, 1995, wherein HCX, Inc. assigned a security interest in all of its rights, title and interest in all servicemarks owned by HCX, Inc. to the Secured Party to secure certain obligations; and

1 Secured Party does hereby release all of its right, title and interest (if any) in and to all of the servicemarks assigned to it by means of the Security Interest and any amendment thereto, including but not limited to those set forth on Exhibit A attached hereto, to HCX, Inc., said servicemarks to be held and enjoyed by HCX, Inc. for its own use and behalf and for its legal representatives, successors and assigns, as fully and entirely as the same would have been held by Secured Party had this Termination of Security Interest not been made. This Release is made without representation or warranty by, or recourse to, the Secured Party.

2 Secured Party acknowledges that HCX, Inc. has no obligations remaining under this Security Interest and hereby terminates the Security Interest.
