TRADEMARK ASSIGNMENT

This Trademark Assignment is by and between Ludlow Corporation, a Massachusetts corporation (hereinafter "LUDLOW") and The Ludlow Company LP, a Delaware limited partnership composed of Graphic Controls Corporation, a New York Corporation, (hereinafter "THE PARTNERSHIP"). LUDLOW and THE PARTNERSHIP may at times be referred to hereinafter individually as a Party or collectively as the Parties.

WHEREAS, LUDLOW is the owner of the trademark SOFT-E (hereinafter "THE TRADEMARK"), which trademark is the subject of United States Registration No. 1,703,078, issued July 28, 1992 to Contour Medical Technology, Inc. and later assigned to Ludlow Corporation, as shown by records of the Patent and Trademark Office at Reel 1749/Frame 0705, (hereinafter "THE REGISTRATION");

WHEREAS, THE PARTNERSHIP is desirous of acquiring THE TRADEMARK and THE REGISTRATION;

WHEREAS, LUDLOW wishes to assign THE TRADEMARK and THE REGISTRATION to THE PARTNERSHIP and THE PARTNERSHIP wishes to accept the assignment of THE TRADEMARK and THE REGISTRATION;

NOW, THEREFORE, BE IT KNOWN THAT, effective February 17, 1999, for good and valuable consideration, the receipt of which is hereby acknowledged, LUDLOW hereby assigns and transfers to THE PARTNERSHIP all right, title, and interest in and to THE TRADEMARK and THE REGISTRATION, together with the goodwill of the business symbolized by THE TRADEMARK, including the right to seek and obtain for THE PARTNERSHIP'S own benefit injunctive relief and recovery of damages for any past and/or future infringements, including enhanced damages and/or attorneys' fees for willful infringement.
