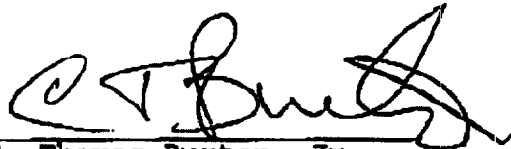

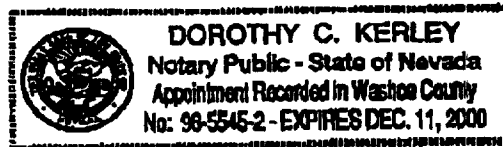

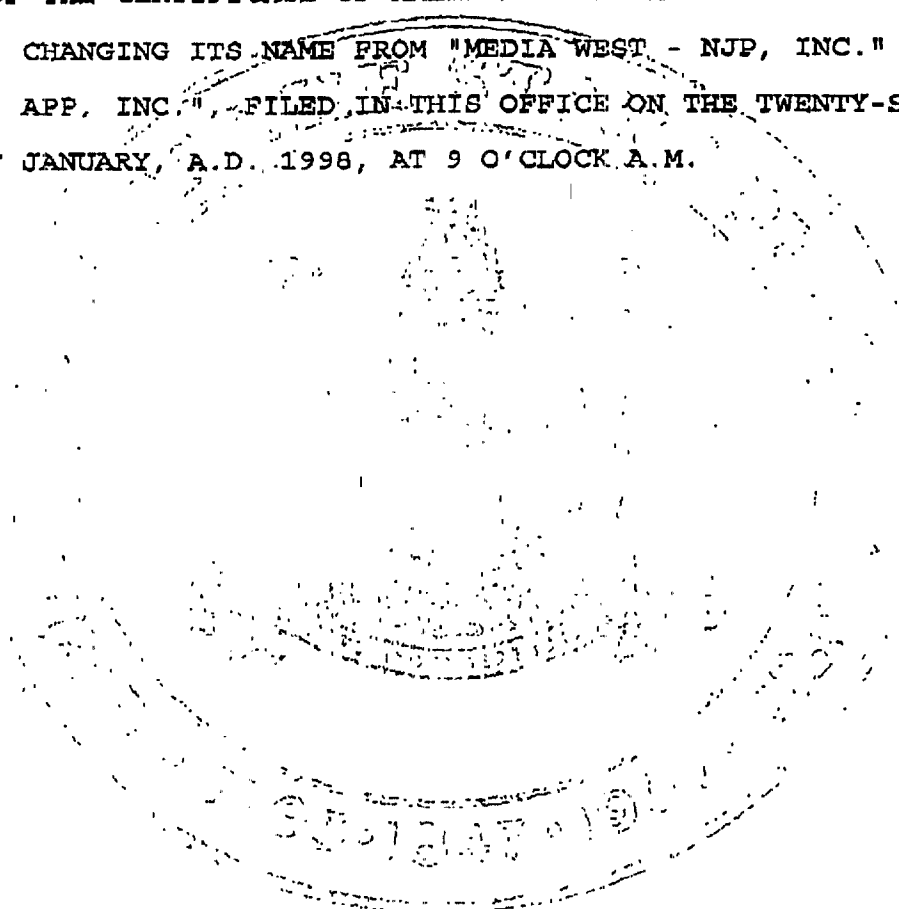

1. Amendment. Section I of the certificate of incorporation is amended to read as follows:

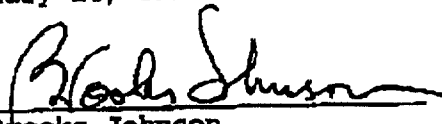

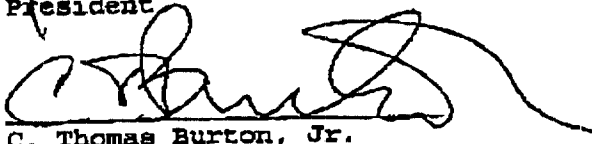
2. No Stock Payment. The Corporation has not received any payment for any of its stock.
