THIRD AMENDMENT TO
TRADEMARK AND SERVICEMARK SECURITY AGREEMENT

This THIRD AMENDMENT TO TRADEMARK AND SERVICEMARK SECURITY AGREEMENT dated as of June 1, 1999 ("Third Amendment"), made by Trade Press Publishing Corporation, a Wisconsin corporation with an office and mailing address at 2100 West Florist Avenue, Milwaukee, Wisconsin 53209 ("Assignor") to Bank One, Wisconsin, f/k/a Bank One, Milwaukee, National Association ("Bank").

WHEREAS, Assignor, Bank and NORWEST BANK MINNESOTA, NATIONAL ASSOCIATION ("Norwest") entered into a Trademark and Servicemark Security dated as of November 30, 1988 ("Trademark Agreement"); and

WHEREAS, Assignor, Bank and Norwest entered into an Amendment to Trademark and Servicemark Security Agreement dated December 23, 1992 whereby the Bank was substituted for Norwest in all respects; and

WHEREAS, Assignor and Bank entered into a Second Amendment to Trademark and Servicemark Agreement dated September 16, 1994 to add additional collateral to be covered by the Trademark Agreement and now wish to further amend the Trademark Agreement to add yet more collateral:

NOW, THEREFORE, in consideration of the premises, the parties hereto agree as follows:

1. Schedule A of the Trademark and Servicemark Security Agreement is amended by adding the trademarks, trade names, service marks, and trade name, trademark and service mark

applications listed on Exhibit A hereto. Schedule A as so amended is complete, true and correct in all respects.

2. Assignor agrees to execute such other documents as may be required to effect the foregoing.

3. Except to the extent otherwise provided herein, all other terms and conditions of the Trademark Agreement, as amended shall remain in full force and effect as originally stated. This Third Amendment to the Trademark Agreement shall be binding upon the parties hereto and their respective successors and assigns.


