Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following Articles of Amendment:

Article I The name of the Corporation:
Qualitest Products, Inc.


Article II The following amendment was adopted in the manner provided for by the Alabama Business Corporation Act:

RESOLVED that the Articles of Incorporation of **Qualitest Products, Inc.** shall be, and the same hereby are amended by striking the words, "**Qualitest Products, Inc.**" and by substituting in lieu thereof the words, "**Qualitest Pharmaceuticals, Inc.**" and that henceforth the name of the Corporation shall be, **Qualitest Pharmaceuticals, Inc.**

RESOLVED that the par value of the common stock of the Corporation shall be changed from \$1.00, per share, to \$0.001, per share; that the total number of shares which the Corporation is authorized to issue shall be increased from 1,000 to 1,000,000 shares; that Stock Certificate # 1, for 1,000 shares of the \$1.00 par value stock, which is currently issued to William S. Propst, Sr., shall be surrendered to, and cancelled, by the Secretary of the Corporation, and, as replacement stock, Stock Certificate # 2, for 1,000,000 shares of the \$0.001 par value stock shall be issued and delivered to William S. Propst, Sr.

Article III The amendment was adopted by the sole director of the Corporation, in the manner prescribed by law on February 1, 1997. Shareholder action on the amendment is not required.
