ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

ARTICLE I

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, National Flood Information Center, Inc. (the "Corporation") hereby adopts these Articles of Amendment to its Articles of Incorporation.

ARTICLE II

Article One of the Articles of Incorporation of the Corporation, as amended, is hereby amended to read in its entirety as follows:

"ARTICLE ONE

The name of the corporation is FLOOD DATA SERVICES, INC."

ARTICLE III

Such amendment made by these Articles of Amendment has been effected in conformity with the Texas Business Corporation Act and was duly adopted by the directors and shareholders of the Corporation on August 23, 1993.


ARTICLE IV
