TRADE MARK ASSIGNMENT

THIS ASSIGNMENT is made the 15th day of November 1999 BETWEEN **HALLITE SEALS INTERNATIONAL LIMITED of 130 Oldfield Road, Hampton, Middlesex, TW12 2HT** ("the Assignor") of the one part AND **TIMBREN INDUSTRIES INCORPORATED of 381 Westney Rd. S., Ajax, Ontario, Canada L1S 6M6** ("the Assignee") of the other part

WHEREAS

1. The Assignor is the proprietor of Trade Mark Registrations AEON (word) No.684651 in the USA and No.155856 in Canada ("the Trade Marks").
2. The Trade Marks are currently registered in the former name of the Assignor, Hallite Seals Limited. The Assignor changed its name from Hallite Seals Limited to Hallite Holdings Limited on 29 April 1985 and then subsequently changed its name again to its current name of Hallite Seals International Limited on 31 August 1988.
3. The Assignor has agreed that the Trade Marks shall be assigned to the Assignee for the consideration hereinafter appearing.


NOW THIS ASSIGNMENT WITNESSES as follows:



In consideration of the sum of CAN\$5,000.00 (Five Thousand Canadian Dollars) paid by the Assignee to the Assignor the receipt of which is hereby acknowledged, the Assignor WITH FULL TITLE GUARANTEE hereby assigns to the Assignee ALL THAT the said Trade Marks together with the goodwill symbolised in the Trade Marks in the United States of America and Canada with the right of the Assignee to bring action and claim relief in respect of any infringement of the Trade Marks occurring prior to the date hereof TO HOLD the same unto the Assignee absolutely.

The Assignee agrees that it will bear the costs of the recordal of the assignment of the Trade Marks at the national trade mark registries in the United States of America and Canada, together with the costs of renewal of US Registration AEON No.684651 beyond 8 September 1999, but not the costs of recording the changes of name of the Assignor to Hallite Seals International Limited against the Trade Marks which shall be borne by the Assignor.

3. The Assignor agrees to execute any further documents and do all further acts or things which may be necessary or desirable to vest absolutely all right title and interest to the Trade Marks in the Assignee and to enable the Assignee to record this Assignment of the Trade Marks at the national trade mark Registers of the United States of America and Canada.
