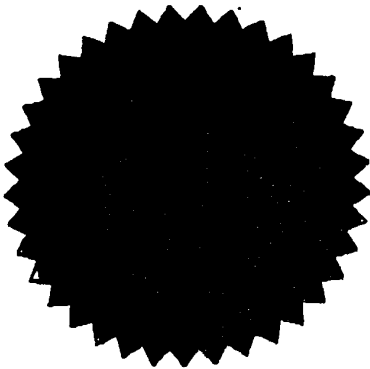

The name of the Corporation is C LEVEL DESIGN, INC. (the "Corporation" or the "Company").
