

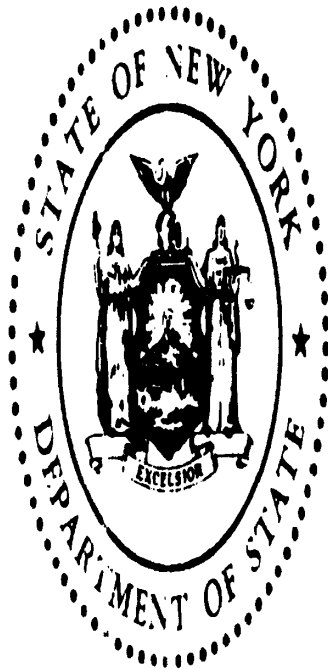

Certificate of Conversion of Courtroom Television Network to Courtroom Television Network LLC under Section one thousand six of the Limited Liability Company Law

The undersigned, desiring to convert a general partnership (the "Partnership") to a limited liability company (the "Limited Liability Company") pursuant to the New York Limited Liability Company Law, Chapter 34 of the Consolidated Laws (the "LLCL"), hereby certifies as follows:

1. This Certificate of Conversion is filed with the Secretary of State of the State of New York pursuant to Section 1001 of the LLCL and is to be effective immediately.

2. The name of the Partnership was Courtroom Television Network.

hereby designated as agent of the Limited Liability Company upon whom service against the Limited Liability Company may be served.



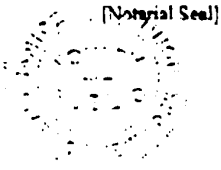
