
**TERMINATION OF

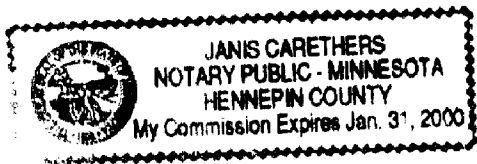
