ASSIGNMENT OF TRADEMARKS

The ASSIGNMENT OF TRADEMARKS is effective as of October 13, 1999 between the parties herein.

WHEREAS, SFX RADIO NETWORK, INC., a Pennsylvania corporation having a principal place of business at 116 East 27th Street, New York, New York 10016, (hereinafter referred to as "ASSIGNOR"), is the owner of the trademarks and record owner of the United States trademark registrations and applications set forth in the SCHEDULE OF TRADEMARKS annexed hereto and made a part thereof, (hereinafter referred to as the "TRADEMARKS"); and
